- **MoCollaboration with:** The Heraklion Bar Association / Heraklion Medical Association / 7th Health Regional Authority/ The FORTH Institute/ Municipalities in Crete
- A member of the major European & National Networks (EFJCA, WAVE, WWP EN, EuroChild, Victims Support Europe, The Hellenic Network for the right to sustainable housing)
- Collaboration with more than 10 Research Institutes in Greece & Europe
- **A training hub for Professionals:** 158 professionals trained (2024), joint (informal) protocols School interventions (50 / 2024)
- A solid database of cases of Violence Against Women and children in Crete (2024, 2025)
- A solid and up to date understanding / research of the phenomenon and its properties

The FJC_Crete


Started at 2023 (SUNNS Project – Regrants scheme)

- Development of a Multi-agency Center on GBV and DV in Crete and adaptation on the local context
- Reinforcing Multi-agency collaboration among relevant stakeholders
- Enhancing the role of civil society Organizations as watchdog for women's right
- Up-scaling the local multi-agency model on the national level

Actions

- Internal & External c/b for multiagency and coordinated response
- Voices of Women and Perpetrators

The change needs time..

The Lessons learned

- ✓ The **VOICES of Women and Men upscaled !!!**
- ✓ Realized the barriers and solutions for multidisciplinary work of f/l professionals. We raised the Questions and we reach the answers..
- ✓ The Crete FJC is not a single and stand alone “One Stop Shop” for providing services for Women !
 - ✓ The Crete FJC is an innovative Hub of professionals “ready to support” the “wants” & needs of Women girls and children !
- ✓ We have seen “frustrated” women and “frustrated” men by their experience with the “**system**” → targets for advocacy, and system’s response → “convenient to the user principle / fast & effective process for women protection
- ✓ **Regional MultiAgency Mode of Response (Crete)**
- ✓ **A training HUB for professionals (of all disciplines)**
 - How we “listen” to the “voice of the Police” and how we respond and collaborate with?
 - What are the “needs” of Police?
 - How well we understand the “voice” and perspective of the Judicial side?
 - How we AVOID the re-traumatization (women / children)?
 - How well could we shift to move from the “silo work” to multidisciplinary mode of work for f-l professionals?
- ✓ **and Innovation HUB for multidisciplinary Work**
 - Data sharing in safety
 - Child protection through the Judicial System
 - ICT tools for collaborative work
 - Risk assessment tools and AI for the benefit of women
 - Trauma Informed Approach as a **mainstream approach for f/l professionals**
 - Addressing multiple vulnerabilities (problematic substance use, Homelessness)

The core pathways of research innovation and experimenting



The challenges..

- Upscaling & Mainstreaming its operation
- Mainstreaming of the **Voices of Women & Voices of men**
 - Understand their “needs” and “wants”
 - Participation mechanism towards actions for “system response upscale”
 - Include the “Voice of Children” as a mechanism of *child participation*
- Position of the FJC of UWAH to the regional ecosystem
- The “safe” hub for professionals of different disciplines
- Advocacy for the institutional dialogue for the significance of FJCs towards combating Violence against Women in Crete & Greece
- Engagement of well experienced professionals to the operation of the FJC
- The pivotal role towards the Regional Multiagency / Coordinated Response model proposition
